GRANT FUNDS MEDICATION-ASSISTED TREATMENT TO REDUCE OPIOID-RELATED DEATHS

*Project is a partnership of Monroe Plan, GBUACO, and Endeavor Health Services
to expand access to MAT treatment for Medicaid recipients*

BUFFALO, N.Y., October 18, 2018 – The Substance Abuse and Mental Health Services Administration (SAMHSA) has awarded a three-year, \$1.5 million grant to Monroe Plan for Medical Care, a not-for-profit Medicaid managed care organization, to enhance access to medication-assisted treatment (MAT) services for Medicaid recipients with opioid use disorder (OUD). The Greater Buffalo United Accountable Care Organization (GBUACO) and Endeavor Health Services (Endeavor) will work in partnership to help deliver the project titled, *“Addressing Buffalo’s Opioid Epidemic with Medication-Assisted Treatment.”* GBUACO is a New York state-authorized Medicaid accountable care organization, and Endeavor Health Services, is a private, not-for-profit organization that provides a wide array of behavioral health services.

Joseph Stankaitis, M.D., M.P.H., Monroe Plan Chief Medical Officer, stated, “Addiction to medical or street opioids has become a scourge in Western New York. This grant allows us to offer evidence-based treatment to some of the most vulnerable individuals in our community by closely collaborating with both GBUACO and Endeavor Health Services.”

The project will expand access to MAT services, including the medications buprenorphine and naltrexone, to primary care doctors in the GBUACO network and their patients with OUD. The goal of the program is to reduce opioid misuse and overdose deaths among Medicaid beneficiaries in Erie County. According the Erie County Health Department, 268 county residents died of a confirmed or suspected opiate overdose in 2017.

“Long-lasting changes in brain chemistry can cause difficulty with abstaining from opioid use; withdrawal symptoms and cravings can be overwhelming,” said Raul Vazquez, M.D., chief executive officer of GBUACO. “MAT can help reduce withdrawal symptoms and curb opioid cravings that can lead to relapse. In fact, studies show that long-term MAT has an 85% chance of reducing mortality among people with OUDs. The importance of this SAMHSA grant cannot be overstated.”

“We are excited to be able to partner with Monroe Plan and GBUACO to offer this much needed service to the community,” said Elizabeth Mauro, LCSW-R, Endeavor Chief Executive Officer. “Our approach to Medication Assisted Treatment is comprehensive, and utilizes a holistic, interdisciplinary approach in the treatment of alcohol and substance abuse. Individuals have access to a wide range of behavioral and physical health services provided where and when they need it.”

Among other objectives, the program is designed to drop the incidence of illicit opioid use and prescription opioid misuse among project participants from a baseline of 56% to 45% by the end of 2019; to 42.5% in 2020; and to 40% by the end of 2021. By the end of each project year, 90% of GBUACO's primary care doctors will have completed trainings and adopted consistent evidence-based MAT treatment guidelines. A full 100 percent of GBUACO's primary care physicians will have daily access to support from addiction medicine practitioners. By the end of September 2019, 70 percent of all GBUACO practices will have a primary care doctor certified to prescribe MAT pharmaceuticals.

Endeavor (formerly known as Mid-Erie) will be co-locating behavioral health counselors at the GBUACO primary care sites to provide counseling as part of the comprehensive treatment approach in using Medical-Assisted Treatment for Opioid Use Disorder.
